OSHA's FY 2022 Outreach Initiatives

I. National Initiatives

OSHA will conduct the following national outreach initiatives:

• <u>Stand-Up 4 Grain Safety Week</u>

This annual event raises awareness of hazards in grain storage and handling operations. March 29 – April 4-8, 2022 will be the sixth annual Stand-Up Week and is sponsored by the OSHA and National Grain and Feed Association (NGFA), Grain Handling Safety Council (GHSC), and Grain Elevator and Processing Society (GEAPS) national Alliance and other agricultural industry groups.

• Fall Prevention Campaign

OSHA's Fall Prevention Campaign raises awareness of the danger of falls in construction and other industries. The signature event is the annual <u>National Safety Stand-Down to Prevent Falls in</u> <u>Construction</u>, which encourages employers to set aside time during the week to focus on fall prevention efforts and training. The Stand-Down typically coincides with <u>Construction Safety</u> <u>Week</u>: May 2-6, 2022.

Heat Illness Prevention Campaign

OSHA continues its efforts to educate employers and workers on heat injury and illness prevention in outdoor and indoor work settings, and the importance of three key safety measures: "Water. Rest. Shade." This campaign is ongoing; however, OSHA amps up outreach efforts during warmer months.

• <u>Safe + Sound: Campaign for Safety and Health Programs</u>

The Safe + Sound Campaign encourages employers to implement safety and health programs. The signature event is <u>Safe + Sound Week</u>, when employers can show their safety commitment through activities related to core elements of safety and health programs: management leadership, worker participation, and a systematic approach to finding and fixing hazards. Safe + Sound Week 2022 will be in August.

<u>Suicide Prevention Awareness Campaign</u>

Suicide is a complex public health problem with lasting harmful effects on individuals, families, and workplaces. OSHA will amplify its outreach and support activities and events in commemoration of Suicide Prevention Awareness Month in September 2022, and World Suicide Prevention Day on September 10, 2022.
